o***Each shipment shall be accompanied by an ORIGINAL signed document from the producer/manufacturer/shipper 1) identifying the country of origin and confirming that the wild avian material was NOT collected in a) Canada between November 1, 2014 and September 30, 2015, b) the European Poultry Trade Region (EU-PTR see below) or Switzerland, or c) any of the countries listed below which are affected with HPAI or have an HPAI control zone; OR 2) confirming that the avian material was subjected to one of the following viral inactivation treatments prior to transport: (a) heated to a minimum of 60°C for at least 30 minutes, (b) immersed in a minimum of 10% formalin, (c) immersed in a minimum of 70% alcohol, (d) immersed in phenol/chloroform, (e) heated to a minimum of 100° C for at least 20 minutes, (f) heated to a minimum of 56°C for at least 3 hours, (g) immersed in a minimum of 3% beta propiolactone for at least 12 hours at 4°C at pH 7, (h) immersed in a minimum of 2% sodium dodecyl sulfate (SDS) for at least 30 minutes, (i) proteinase K, (j) treated with guanidine HCl and/or (k) spotted on Whatman FTA cards (for liquids only).

[This certification must CLEARLY correspond to the shipment by means of an invoice number or shipping marks or lot number or other identification method.]

- ***Countries/regions considered by USDA to be affected with highly pathogenic avian influenza (HPAI) and/or to have an HPAI quarantine control zone as of the issuance of this permit include: Afghanistan, Albania, Azerbaijan, Bangladesh, Benin, Bhutan, Burkina Faso, Cambodia, Cameroon, China, Djibouti, Egypt, Ghana, Hong Kong, India, Indonesia, Iran, Iraq, Israel, Ivory Coast (Côte d'Ivoire), Japan, Jordan, Kazakhstan, Kuwait, Laos, Lebanon, Libya, Macau, Malaysia, Mexico, Myanmar, Nepal, Niger, Nigeria, North Korea, Pakistan, Palestinian Autonomous Territories, Romania, Russia, Saudi Arabia, South Africa, South Korea, South Sudan, Sudan, Taiwan/Chinese Taipei, Thailand, Togo, Turkey, Ukraine, and Vietnam.
- o ***Untreated wild bird material originating from Switzerland and/or the APHIS-defined European Poultry Trade Region (EU-PTR) is not permitted under this permit. The EU-PTR includes the following countries: Austria, Belgium, Cyprus, the Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Poland, Portugal, Slovakia, Slovenia, Spain, Sweden, and the United Kingdom (England, Scotland, Wales, the Isle of Man, and Northern Ireland).
- For the purposes of this permit, "untreated material" is defined as material that has not undergone an APHIS approved disease mitigation procedure.
- With the exception of material listed below, all studies with UNTREATED bird material must be conducted in your Biosafety Level 2 (BSL-2) facility located at the University of Washington, Burke Museum, Corner of 17th Ave NE and NE 45th Street, Rms 28 and 206, Seattle, Washington, which have been inspected and approved by the USDA. These facilities shall be reinspected every 3 years.

RESTRICTIONS AND PRECAUTIONS: (continued from Permit Form VS 16-6)

- Untreated material derived from wild birds that originated in regions free of both virulent Newcastle disease (ND) and HPAI and having no HPAI quarantine control zones is not restricted to BSL-2 requirements (unless exposed to untreated bird material sourced from other regions). This includes wild avian material collected in Argentina, Australia, Canada (except material collected from November 1, 2014 through September 30, 2015), Chile, Costa Rica, Fiji, Iceland, and New Zealand.
- Importing facility is subject to routine inspection by USDA, APHIS personnel during normal business hours to ensure compliance with permit restrictions.
- Permittee shall notify USDA, APHIS, Veterinary Services within 48 hours of failure of receipt of a shipment of materials. Permittee to contact (301) 851-3300, option 1.
- Personnel working with material that is restricted to the BSL-2 facility using procedures that may result in aerosolization (such as harvesting tissues, aspirating, dispensing, mixing, centrifuging) must either work under a biosafety cabinet or wear extra personal protective equipment (i.e. disposable coveralls, masks, gloves, headwear, and footwear) to prevent the inadvertent transport of pathogens to the outside environment or exposure of humans, domestic animals, and wildlife to potentially hazardous agents.
- Personnel must have no contact with live birds (including poultry, pet birds and wild birds) for a minimum of 5 days after working with bird material that is restricted to the BSL-2 facility.
- This permit DOES NOT authorize direct or indirect exposure of or inoculation into laboratory and domestic livestock, (including but not limited to: birds/poultry, cattle, sheep, goats, swine, and/or horses). Work shall be limited to in vitro uses only.
- Packaging, containers, and all equipment in contact with these materials shall be sterilized or considered a biohazard and be disposed of accordingly.
- •BSL-2 restrictions may be relieved for bird material that is subjected to one of the following APHIS approved viral inactivation treatments (unless exposed to untreated bird material still under BSL-2 requirements): (a) heated to a minimum of 60°C for at least 30 minutes, (b) immersed in a minimum of 10% formalin (c) immersed in a minimum of 70% alcohol, (d) immersed in phenol/chloroform, (e) heated to a minimum of 100°C for at least 20 minutes, (f) heated to a minimum of 56°C for at least 3 hours, (g) immersed in a minimum of 3% beta propiolactone for at least 12 hours at 4°C at pH 7, (h) immersed in a minimum of 2% sodium dodecyl sulfate (SDS) for at least 30 minutes, (i) proteinase K, (j) treated with guanidine HCl and/or (k) Spotted on Whatman FTA cards (for liquids only). Records of treatment (including identification of treated material and treatment applied shall remain on file and made available to USDA upon request.

- oThis permit is valid only for work conducted or directed by you or your designee in your present U.S. facility. MATERIALS SHALL NOT BE MOVED TO ANOTHER U.S. LOCATION, OR DISTRIBUTED WITHIN THE U.S. ++EXCEPTIONS: 1) Materials restricted to BSL-2 facilities may be transported directly to the approved USDA BSL-2 lab specified on a valid USDA, APHIS, VS, NIES transport permit issued to the recipient. Sender and recipient must adhere to all conditions on the transport permit. 2) Materials that have been treated with one of the viral inactivation methods specified above may be distributed if accompanied by a signed document confirming the viral inactivation treatment that has been applied. HOWEVER, any treated bird material that has been exposed to untreated bird material that is restricted to the BSL-2 facility may not be distributed without being subjected again to one of the viral inactivation treatments listed above. In all cases, records of distribution (including dates, locations, and material identity, origin and treatment applied (if applicable) must be maintained and made available to USDA upon request.
- On completion of your work, all permitted materials and all derivatives therefrom shall be destroyed.
- o Imported material may be subject to regulations enforced by the United States Department ofInterior, Fish and Wildlife Service (FWS). Importer must contact FWS. Information is available at web pages http://www.fws.gov/permits/ and http://www.fws.gov/le/travelers.html.
- This permit does not exempt the permittee from responsibility for compliance with any other applicable federal, state, or local laws and regulations.
- $oldsymbol{o}$ The restrictions on this permit remain in force as long as the material is in the United States.
- Any person who VIOLATES the terms and conditions of permits, and/or who forge, counterfeit, or deface permits may be subject to criminal and civil penalties in accordance with applicable law. In addition, all current permits may be cancelled and future permit applications denied.
- •A copy of this permit must be included with the shipping documents. For imported materials, these documents must be presented to CBP Agricultural Specialists upon arrival at the U.S. port of arrival.
