### CONDITIONS OF APPROVAL

Permission to reproduce images of works of art from the University of Alaska Museum of the North is granted upon acceptance of the conditions described below. Any breach of the following terms and conditions will result in revocation of permissions at the discretion of the UAMN.

- All requests for image use and reproduction must be made in writing.
- Color transparencies are rented for a 3-month period, and will not be sold outright. A \$25.00 fee will be assessed for each additional month after the 3-month rental period.
- 35mm slides may not be used for reproduction in publications, video, film, electronic media or for duplication.
- Black & white prints and digital files are for sale, and are not to be returned.
- Payment is in UNITED STATES currency for all orders, and must be made to University of Alaska Museum of the North, 907 Yukon Drive, PO Box 756960, Fairbanks, AK 99775-6960
- All reproductions must be made from photographic materials supplied by the UAMN. Reproduction from non-photographic materials is strictly prohibited.
- Full documentation of the object reproduced must accompany the reproduction, either directly beneath, on a facing page, on the reverse, or elsewhere in a publication such as an image list. In the case of electronic media (television, video, DVD, CD) a general attribution must appear in production credits. For reproductions published on the internet, credit must accompany the reproduction either beneath the image or next to it.
- Permission is granted for one usage in one publication, one edition, and in one language. Any further reproduction will require an additional fee and written permission from the UAMN.
- The reproduction must be printed in full tone black and white or full color and may not be reproduced on colored stock. Nothing may be superimposed over the image without approval from UAMN.
- The image must be reproduced in its entirety and must not be bled off of the page or cropped in any way without permission from the UAMN. The reproduction of a specific detail must be approved in advance by the UAMN and the fact that it is a detail noted in the documentation accompanying the reproduction.
